SATELLITE CLINICS

MNR DENTAL COLLEGE AND HOSPITAL, SANGAREDDY

MNR dental college & Hospital had set up two satellite centers at Hathnoora and Veerabadrapuram with the aim to help village people and prevent the spread of oral diseases thus improving the general oral health status of the rural population.

HATHNOORA:


Hathnoora clinic is approximately 30 km from the dental college and was set up on 11th November, 2012. The clinic is equipped with one dental chair and has an average of 14 (new OP appx 7 and old op appx 7)

VEERABADRAPURAM:

Veeraadrapuram clinic is approximately 15 km from the dental college and was set up on 6th July, 2013. The clinic are equipped with two dental chairs in Veerabadrapuram and has an average of 19 (new OP appx 12 and old op appx 7)

In both the satellite clinics oral prophylaxis, minor fillings, extractions will be done and simultaneously spread awareness and attend the oral needs of people with care. Patients requiring higher levels of treatment are referred to MNR Dental Hospital.

Internees of the Department of Public Health Dentistry are posted to the satellite clinics on regular basis. The teams are repositioned in different locations as per the need of the hour.

Subject: Creation of Setup of Satellite Clinics in remote areas for Internship compulsory requirement of the DCI Revised BDS Course (3rd Amendment) Regulations, 2011.

Sir/Madam,

I am directed to refer to the subject cited above and to say that the revision of the 5 year BDS curriculum to the 4+1 year duration was done with the clear intention of providing adequate clinical exposure to the students during their internship period. As a part of this proposal, all dental institutions were required to setup Satellite Clinics to support a rural outreach dental program and facilitate the clinical exposure of the interns.


2. The relevant section of the DCI Revised BDS Course (3rd Amendment) Regulation, 2011 is reproduced hereunder for your ready reference:-

*11. Rural Services

- In the rural services, the student will have to participate in-
1. Community Health Monitoring programmes and services which include Preventive, Diagnostic and corrective procedures
 2. To create educational awareness about dental hygiene and diseases.
 3. Conduction of Oral Health Education Programme at -
(a) School Setting
(b) Community Setting - 5
(c) Adult Education Programme - 5
 4. Compulsory setup of satellite clinics in remote areas - 5
 5. Lectures to create awareness and education in public forums about the harmful effects of tobacco consumption and the predisposition to oral cancer - two Lecturers per student." - 1

3. With the above, I am directed to request you to kindly take the necessary action on the above provisions as prescribed in the DCI Revised BDS Course (3rd Amendment) Regulations, 2011 and furnish the details to the DCI about the Satellite Clinics Setup by your Institution in the remote areas.
